# AMENDMENT TO THE DECLARATION OF AMENDED PROTECTIVE COVENANTS NORTH ELK MEADOWS FILING 11

(As Recorded of Gunnison County Public Record in Book 632, pages 493-505)

The undersigned owners of real property in North Elk Meadows Filing 11 hereby attest and approve amendment of the Declaration of Protective Covenants for North Elk Meadows, as follows:

## This current language:

- 4.A. <u>Single Family Dwelling Lots</u>. Lots 1 through 24, both inclusive, to be used exclusively for one single family dwelling per lot.
- 4.B. <u>Commercial Lots</u>. Lots 25 and 26 shall be used exclusively for stores in retail trade, service establishments, a restaurant and lounge, offices, recreational facilities, and other such similar uses not more detrimental to the area than those specifically enumerated herein. The restaurant and lounge and recreational facilities shall only be constructed upon lot 26. Each retail trade establishment may not exceed 3,000 square feet of interior floor space in the aggregate. In addition to retail trade establishments, only one restaurant and lounge facility, and a total of two additional commercial establishments, whether offices or service establishments, shall be permitted on both of said commercial lots.

The owner of either of said commercial lots shall have the right to purchase all or any adjoining portion of the other commercial lot in order to accomplish a relocation of the common boundary line between said commercial lots depicted upon the recorded amended subdivision plat, so long as such sale and purchase shall not decrease the size of an original lot to less than 1.00 acre, unless the entire lot is purchased.

## Shall be changed to:

- 4.A. Single Family Dwelling Lots. Lots 1 through 25, both inclusive, to be used exclusively for one single family dwelling per lot.
- 4.B. <u>Commercial Lot</u>. Lot 26 shall be used exclusively for stores in retail trade, service establishments, a restaurant and lounge, offices, recreational facilities, and other such similar uses not more detrimental to the area than those specifically enumerated herein. Each retail trade establishment may not exceed 3,000 square feet of interior floor space in the aggregate. In addition to retail trade establishments, only one restaurant and lounge facility, and a total of two additional commercial establishments, whether offices, or service establishments, shall be permitted on lot 26

The owner of either lots 25 or 26 shall have the right to purchase all or any adjoining portion of the other lot in order to accomplish a relocation of the common boundary line between said lots depicted upon the recorded amended subdivision plat, so long as such sale and purchase shall not decrease the size of an original lot to less than 1.00 acre.

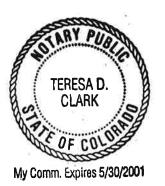
